**Nondeductible Dues:** Compliance with the Tax Reform Act of 1993, as amended by the Tax Cuts and Jobs Act of 2017, requires that the portion of dues attributable to lobbying and political activities at the Local, State and Federal levels of government be considered nondeductible for income tax purposes.

For 2025 dues of \$156 per member, **NAR** computes 35 percent or \$55 to be nondeductible for the member's income tax due to NAR lobbying efforts. Note that the entire \$45 consumer advertising campaign special assessment qualifies as fully deductible. In addition, contributions (including member dues) to NAR are not tax deductible as <a href="mailto:characteristics.com/characteristics.c

For 2025 dues of \$120 per member, the **NYSAR** portion that is not deductible for income tax purpose is \$25.
